The DOAG Premium Card is a framework agreement for discounted participation in DOAG events. In addition to these guidelines & GTC Premium Card, the conditions and announcements for the respective event as well as, if applicable, special conditions for additional services according to the individual booking apply.

These conditions of participation apply exclusively to entrepreneurs within the meaning of § 14 BGB (German Civil Code). Entrepreneurs within the meaning of § 14 BGB are also persons who act in their commercial, professional or self-employed sphere of activity when concluding the contract. The offer of DOAG is not aimed at consumers within the meaning of § 13 BGB. If you are a consumer in this sense, please contact us.

1 Services of the DOAG Premium Card

1.1 Members of DOAG may purchase the DOAG PREMIUM CARD for the annual fee stated in the separate General Terms and Conditions.

1.2 Within the scope of the capacities, the cardholder receives free access to DOAG events as well as to the electronic documentation of previous events of the calendar year with the DOAG PREMIUM CARD.

1.3 The events of the respective calendar year are specified in the service description. The DOAG may update this list during the year. It is possible to add events at any time; the removal of events is only permitted if the event is not carried out.

1.4 The freedom from costs does not apply to travel, accommodation and food costs not associated with participation, unless stated in the conditions of the event.

1.5 Holders of the DOAG PREMIUM CARD must in any case register online for the respective events under the conditions of the respective event. The cost-free is taken into account. Registration on site is not possible.

1.6 If the cardholder registers and is prevented from participating, he is obliged to cancel the registration immediately. In any case, the cancellation is free of charge, even if the cancellation conditions provide for payment. If the cancellation is not made in good time before the start of the event, DOAG may collect the DOAG PREMIUM CARD. The cardholder is then no longer entitled to benefits. If the cardholder has been prevented from cancelling in good time through no fault of his own and proves this, no collection will take place.

2 Conclusion of contract and terms of payment

2.1 The contract for the DOAG PREMIUM CARD is concluded by booking via the DOAG shop.

2.2 The cardholder is obliged to notify DOAG immediately of any changes to his address data.

2.3 With the conclusion of the contract, the cardholder undertakes to pay the stated fees for the DOAG PREMIUM CARD. The fees are exclusive of the statutory value added tax, which is shown separately. The fee is due on 1 January of each year or at the later start of the contract 10 days after conclusion of the contract and is to be paid to DOAG free of charge within 14 days. Only after receipt of payment can the services of the DOAG PREMIUM CARD be used.

3 Transferability of the DOAG Premium Card

3.1 The DOAG PREMIUM CARD requires membership in the DOAG Deutsche Oracle Anwendergruppe e.V. and is issued personally for the natural member, the representative of a corporate member or for an associate member.

3.2 The DOAG PREMIUM CARD can be transferred to another associate member within a corporate membership if there are no future event bookings for which the card was used at the time of the transfer. The transfer is possible a maximum of once per calendar year.

4 Duration of contract, termination of contract and termination

4.1 The contract for the DOAG PREMIUM CARD is concluded for an indefinite period. The cardholder receives a DOAG PREMIUM CARD for each calendar year after payment of the fee.

4.2 The termination of the contract via the DOAG PREMIUM CARD is possible by written or textual termination with a notice period of twelve weeks to the end of the year. The termination of the DOAG PREMIUM CARD does not also mean the termination of the membership of the DOAG. Termination for good cause is reserved to both contracting parties.

4.3 With the termination of the cardholder's membership or the membership of the respective corporate member in the DOAG Deutsche Oracle Anwendergruppe e.V., the contract ends at the end of the respective current calendar year. This does not apply if the termination of the membership on the part of DOAG takes place for good cause. A refund of fees will not be made in any of the cases.

5 Liability of DOAG to the DOAG Premium Card

DOAG shall only be liable in the event of intentional or grossly negligent action by its representatives and vicarious agents. This does not apply if damages resulting from injury to life, limb or health that are based on a negligent breach of duty by DOAG or an intentional or negligent breach of duty by a legal representative or vicarious agent of DOAG.

6 Place of jurisdiction and choice of law

As far as permissible, Berlin is agreed as the place of jurisdiction. German law is agreed to the exclusion of the UN Convention on Contracts for the International Sale of Goods.
